



ETA EXECUTIVE BOARD ELECTIONS

ETA elections will take place **Feb. 9 – April 19, 2018**. The Executive Board meets prior to each Rep. Council meeting and at such other times as the President may deem necessary. Officers shall be elected for a term of 2 years, commencing on July 1 of any calendar year. The positions that will be open for the 2018-2020 term of office are: **President and Secretary**. In addition, there are **three Member-at-Large positions** as well as **Minority Rep.**

The duties of the Executive Board shall be to:

1. Coordinate the activities of the Association.
2. Act for the Representative Council when school is not in session.
3. Direct the bargaining activities and grievance processing of the Association, subject to policies set by the Representative Council.
4. Approve appointment and removal of bargaining team members.
5. Recommend a budget for the Association to the Rep. Council.
6. Approve Committee appointments.
7. Adopt the Standing Rules for the Association; and
8. Exercise all the business and organizational powers and duties for the Association as prescribed by law and these bylaws.
